ASSEMBLY MEMBERS:

23rd Assembly District: Incumbent Democrat **Marc Berman** (winner) vs Republican Tim Dec

24th Assembly District: Incumbent Democrat **Alex Lee** (winner) vs Republican Bob Brunton.

25th Assembly District Incumbent Democrat **Ash Kalra** (winner) vs Republican Ted Stroll.

26th Assembly District Incumbent Democrat **Evan Low** (winner) vs Republican Tim Gorsulowsky

29th Assembly District Democrat **Robert Rivas** (winner) (previously of 30th District) vs Republican Stephanie Castro

SENATORS:

(Voters in the even-numbered districts will elect a senator to represent them in the 2022 election.)

10th Senate District Incumbent Bob Wieckowski is termed out of office on election day 11/8/22.

Aisha Wahab (winner) vs Lily Mei for the seat. Both are Democrats.

15th Senate District Incumbent Dave Cortese does not have to run in the 2022 election, and will serve until 2024.
