President's report: Laurie Granberry

- She received many emails from NPs such as students looking for preceptors, asking for schedule of meetings and event. She forwards these on to the appropriate BOD member

GRASSROOTS/LEADERSHIP CALLS:

The most recent Leadership/Grassroots Zoom meeting was Monday, March 27, 2023:

CANP Annual Educational Conference: Recently from March 16-19 in Monterey, & welcomed approx 550 attendees. Next year will be at the Disneyland Hotel in Anaheim.

Preceptors: CANP is making plans to facilitate finding preceptors for NP students.

103 NP's: Asked for feedback on applying to BRN for 103 status. FNP's are more easily accepted, but "legacy" applicants who did not have training for the entire lifespan need to complete other requirements. Applicants must also be nationally board certified.

There was resistance from CMA who asked their members not to "attest" for the NP's seeking 103 status. The physicians were told that by doing so, they were "attesting" to the competency of the NP's, and not just a length of time in employment.

BRN NPAC: This new subcommittee of the BRN is creating the process for NP's to become 103's. CANP does not have any members on that committee, even though several applied.

There is an opening for the APRN representative on the BRN, who is appointed by the governor. Aimee Paulson, CANP president elect, offered to send info to those interested in applying for that position.

John Alejandro, CANP VP of Finances:

Issue of government employees (VA) accepting meals at CANP meetings from pharma companies, then not wanting to pay individually for them. John said his chapter paid for the dinners, according to his interpretation of the state CANP statutes.

Karen spoke up & explained that the county employees of our chapter know & follow the guidelines of their workplace & decline to accept meals in those circumstances. It has never been a problem for us.

John suggested approaching the sponsoring pharm groups to establish a "memorandum of understanding" in which the pharma understands that CANP groups expect all government employees to be treated the same as all the other NP's. If they plan to not pay for the government employees' meals, they should make it clear to those NP's before they come to the meetings.

Glenmore Hendricks' HPPC Report: Assembly Bill (AB) 890 for full practice authority still in process of rolling out by the BRN.

Support for Senate Bill (SB) 260. CalWORKS supportive services. Watching AB 765 by Woods. To clarify the use of the title "doctor"

Kristi Patchin: CANP administration requesting being cc'd when sending out announcements of chapter activities or advance schedules.

There will be a survey sent out re activities on Instagram & Twitter.

Next Leadership/Grassroots Zoom meeting: Mon, April 24 at 7-8pm. That agenda requests that the chapter treasurers be included as finances will be discussed.
