# Advocacy

#### <u>SB 491</u>

Senate Bill 491 (Hernandez), which would remove practice barriers for NPs, allowing them to work autonomously without physician supervision, continues to be the centerpiece of this year's advocacy efforts.

SB 491 survived its first policy committee test in the Assembly on August 13, when it was approved by the Committee on Business, Professions and Consumer Protection (B&P Committee) on an 8-2 vote. During the previous week's meeting of the same committee, the bill failed to garner the eight votes necessary for passage. Reconsideration was granted, and the bill was subsequently approved.

The bill is now in the Assembly Appropriations Committee, which has placed the bill on its Suspense File. This practice is common for bills that have been determined to have a fiscal impact on the state budget. The committee's analysis of the bill concludes that it would impose minimal costs on the Board of Registered Nursing for licensing and other routine implementation expenses. The committee will take up the Suspense File during its August 30 hearing. At that time, the bill would need to be removed from Suspense and garner nine "aye" votes from among the 17 members of the committee in order to be referred for a full Assembly floor vote. If passed by the full Assembly, the bill would then need to return to the Senate side of the Capitol for concurrence in amendments that have been made on the Assembly side. Each of these steps will need to be completed by the September 13 end of this year's legislative session in order for the bill to go to the Governor's desk.

Amendments to the bill have been critical to gaining additional support from lawmakers and such organizations as the California Association of Physician Groups (CAPG) and the California Primary Care Association (CPCA). In order to get the bill out of the B&P Committee, Senator Hernandez accepted amendments to remove the "second pathway" to NP autonomy, which would have granted the ability for NPs to practice without supervision in any setting, after having completed three years of physician-supervised experience. Another amendment that was crucial to removing the opposition of the powerful American Federation of State, County and Municipal Employees (AFSCME) stipulates that "a nurse practitioner shall not supplant a physician and surgeon employed by specified health care facilities."

These amendments have prompted some organizations that previously supported the bill, including the American Association of Nurse Practitioners (AANP) and the American Association of Retired Persons (AARP) to reverse course and adopt an "oppose" position. These organizations argue that the amendments have "undermined the objective of the original bill" and have

mischaracterized the bill as placing "even greater restrictions on California NPs than those already in place."

The fact is, the bill in its current form would still permit most nurse practitioners in California to work without physician supervision, a significant achievement given California's existing law that requires physician supervision for all NPs working in all settings. CANP continues to strongly support the bill, believing that incremental gains represent vital steps toward the ultimate goal.

Grassroots efforts are currently focused on members of the Assembly Appropriations Committee. CANP members and allies have been urged to make the case for the bill through face-to-face meetings, phone calls, emails and utilization of CANP's online Grassroots Action Center. Should the bill pass out of the Appropriations Committee, campaigns targeting every member of the Assembly will commence.

# Action for Chapters:

- Urge Chapter members to call, email or send a message through the Grassroots Action Center to members of the Assembly Appropriations Committee to urge support for the bill.
- Urge Chapter members to call and / or arrange meetings at the Capitol or district offices of their local Assembly members to urge support for the bill (pending the outcome of the Appropriations Committee hearing).
- Utilize Grassroots Coordinator Stephanie Tseu (<u>canpgrassroots@gmail.com</u>) as the central contact for information on grassroots efforts.
- Utilize the campaign as a rallying call for non-member colleagues to join our efforts and become a member of CANP
- Designate one Legislative Representative per Chapter as one key contact for the Chapter

## Board of Directors

# Membership

CANP's membership is currently at 2,528 active members as of August 27, 2013. CANP has a new area on the <u>website</u> recognizing all of its corporate partners with a company description and logo.

## Membership Renewals

CANP continuously encourages members to renew their CANP membership. Efforts include placing their membership invoice in their member account online 60 days prior to their renewal date. Second, people are sent an email 30 days prior to their due date and then weekly a month leading up to their expiration date reminding them that their membership is due and encourages them to go online and renew their membership. Third, around their renewal date members are mailed a postcard reminding them to renew. In addition, CANP has resumed sending paper renewal invoices along with a cover letter in the USPS mail.

The CANP Strategic Plan calls for five percent growth in membership this year. In order to achieve this goal, Chapters are asked to motivate members to renew on time, encourage prospective members and colleagues to join, and reach out to continue engagement between Chapter leaders and members.

# Action for Chapters:

- Urge Chapter members who are suspended or expired to renew their membership. This can be done via phone calls or other means of outreach. Reports with contact information are available to Chapter Leaders in the Chapter Leadership toolset online at canpweb.org
- Let Chapter members know that invoices are available up to 60 days prior to their expiration date
- Contact members that haven't attended a meeting lately and re-invite them to attend meetings -- the personal contact provides a great opportunity to re-engage the member
- Offer creative incentives for people to promote CANP membership to colleagues
- Keep members engaged and excited to be a part of the association
  - Offer ice breakers at meetings to facilitate interaction among members
  - Have lightly structured activities at meetings that engage people
  - o Create and maintain a preceptor list for early engagement of students in CANP

National Nurse Practitioner Week is November 10 - 16, 2013. Now is the time to start planning an NP Week celebration for current members and a great opportunity to reach out and invite prospects or NPs that have let their membership lapse.
