Advocacy

Legislative Update

Legislators returned to Sacramento on December 5th to kick-off the 2017-18 Legislative Session. A total of 31 new members were sworn in – nine in the Senate and 22 in the Assembly. Although the 5th was the official beginning of the new, 2-year session, lawmakers have gone back to their districts and will not return to the Capitol again until January 4th, which is the practical start of session and when the real activity begins.

Now that new members have been sworn in, bill introductions have begun and will continue to trickle in over the next two and a half months. The deadline by which all bills must be introduced is February 17th, so, as usual, the bulk of new legislation will surface in February. Democrats now have supermajorities in both the Senate and Assembly, so they will likely utilize this power to make changes to policy that may have been difficult or impossible in previous years. Namely, Democrats can now increase taxes, suspend or waive legislative rules, pass urgency legislation, and overturn the Governor's vetoes without any Republican support. The majority party will also try to pass a transportation funding package, which they were unable to do via the Governor's special transportation session this year, and attempt to tackle affordable housing.

However, the supermajority does not translate to unlimited power. In order for the supermajority to be effective on any one particular issue, nearly all Democrats have to be in agreement, assuming Republicans are opposed. As proven in 2013, the left of center Democrats were often unsuccessful in pushing their more progressive agendas. The power of moderate Democrats (who are typically more business friendly and often reluctant to pass legislation that could be harmful to business) rose significantly then, and the Mod Caucus' influence will likely continue to be felt in 2017.

With Donald Trump's win and Congressional Republicans maintaining their majorities in both the U.S. Senate and House of Representatives, California is the clear political outlier. On November 9th, Senate Pro Tem Kevin de Leon (D-Los Angeles) and Assembly Speaker Anthony Rendon (D-Lakewood) issued a joint press release, stating that they awoke on the morning after the election "feeling like strangers in a foreign land," and that California, as a trendsetter for the rest of the country, will "defend (California's) accomplishments using every tool at (their) disposal."

As California shores up its position as America's progressive beacon, healthcare is one area where the Golden State's legislators could make some changes. President-Elect Trump is promising to repeal the Affordable Care Act (ACA), the impacts of which would not be felt more

in any state than California. The Golden State was the first to create a public health exchange – Covered California – and if the ACA is repealed, resulting in the loss of federal subsidies, up to 7.5 million Californians are projected to be uninsured by 2021. Already, Covered California and its supporters have stated that they will fight to defend the exchange. Legislative Democrats will also undoubtedly fight the Trump Administration on the dismantling of the ACA, so healthcare and Medi-Cal will be a high-profile issue legislatively.

Because 2017 is the first year of a 2-year session, business will ramp up slowly as new legislators find their bearings. After the bill introduction deadline, policy committee hearings will commence in March and run steadily through April, followed by fiscal committee hearings in May ahead of the house of origin deadline. The first few months of 2017 will be a good time to educate new legislators on issues affecting NPs.

November 8, General Election

After nearly a month, the results of the 2016 California General Election are essentially decided, and Democrats rule the day. Votes are still being counted and the results of all contests will not be certified until December 16th, but California's status as a prominent blue state is undisputed. Assembly Democrats easily captured a supermajority by picking up three seats, and although it initially seemed as though Republicans would be able to fend off a Democrat supermajority in the Senate, they were ultimately unsuccessful and the supermajority in the upper house was secured.

Notably, the balance of power in the Legislature going into 2017 mirrors its composition after the 2012 general election, which was when Democrats in both houses initially won supermajorities. In 2014, those supermajorities were lost when Republicans in several swing seats unseated Democrat incumbents. Two of those Assembly Republicans were defeated this year by the Democrat incumbents they defeated in 2014 – David Hadley, who lost to Democrat Al Muratsuchi, and Young Kim, who could not defend her seat against Democrat Sharon Quirk-Silva. The third Republican loss was Eric Linder, who was elected in 2012. He lost to Democrat challenger Sabrina Cervantes.

In the Senate, the Democrat supermajority hinged on the outcome of the race to succeed termed out former Republican leader Bob Huff. After holding the lead for nearly two weeks, Republican Assemblywoman Ling-Ling Chang lost to Democrat Josh Newman, who took the lead due in large part to late and provisional ballots. Despite its shrinkage, many predicted that the legislative losses suffered by the California Republican Party would be greater. Associating Republican incumbents and candidates in swing districts with Donald Trump was a widely-used Democrat strategy, and although it may have contributed to Republican losses in some races, it was ineffective in others, e.g. Republican Catharine Baker easily defended her Bay Area seat, despite efforts by her opponent to tie her to Trump.

On the national stage, Governor Brown startled speculators when he named California Rep. Xavier Becerra (D-Los Angeles) to succeed Kamala Harris as California's Attorney General. Becerra was not among those rumored to be a contender for the post, and his appointment sets in motion what will be a game of musical chairs as potential candidates announce their intention to succeed him in the House of Representatives. Less than an hour after Becerra's appointment was announced, former Assembly Speaker John Perez threw his hat in the ring for Becerra's seat. While there are a number of other Los Angeles politicians who could run to represent the 34th Congressional District, Senate Pro Tem Kevin de Leon (D) has indicated that he will remain in the Senate as Pro Tem.

An onslaught of initiatives filled the California ballot this year, raising a record \$473 million in the months leading up to the election. The 17 ballot measures ran the gamut from prescription drug

pricing and sentencing reform to a tobacco tax and marijuana legalization. Opponents of the tobacco tax, after raising nearly \$41 million against the measure, were unsuccessful in stopping Prop 56. Conversely, voters rejected Prop 61, which sought to control prescription drug pricing. Voters did approve Prop 64, which will legalize recreational marijuana, as well as Prop 55, which will extend the Prop 30 income tax increases on high-income earners.

Grassroots Update

Now that the election is over, chapters should reach out to congratulate newly elected legislators (30 new legislators were sworn into office on December 5) and express your hope for a successful working relationship now that the legislator is sworn into office. Chapters should also start reaching out to new legislators requesting a "meet and greet" where your chapter will educate new legislators about NPs, your role in the community, your practice setting, your educational background, etc. This is the first step in creating a long lasting relationship with the legislator's office. While prioritizing new legislators, remember to keep in contact with existing legislators as well. As you meet with legislators, remember to share your pictures and experiences on social media for all of CANP's membership to see.

Action for Chapters:

 At your next dinner meeting, bring a computer and have your membership find their legislators then have them sign up for the legislator's newsletter so they can be up to date on the legislator's activities and priorities

Social Media

CANP continues to urge all chapter leaders to use social media, especially Twitter, as an efficient and effective way of keeping members updated on grassroots opportunities and ultimately engaging legislators. Every morning CANP receives a report of local legislative meetings. When there are such meetings our chapters should attend, we'll post information via Twitter. This presents incredible opportunities to interact with legislators in your area.

Action for Chapters:

- Register for Twitter and follow <u>@CaliforniaNP</u>
- Designate one Legislative Representative per chapter as one key contact for the chapter
- Continue to meet with legislators to educate and develop a relationship with them, with special emphasis on the role that NPs fill in the healthcare delivery system AND how that role is impeded by current requirements for physician supervision



The Chapter Leadership Toolset is available on <u>canpweb.org</u> for chapter leaders to access reports on new and renewing members for contact and reporting purposes.

CANP has a standing goal of growing membership by 5% annually. In order to achieve this goal, chapters are asked to motivate members to renew on time, encourage prospective members and colleagues to join, and reach out to continue engagement between chapter leaders and members.

Action for Chapters:

- Urge chapter members who are suspended or expired to renew their membership. Let chapter members know that invoices are available up to 60 days prior to their expiration date
- Welcome new members and introduce them at chapter meetings
- Call and ask new members back to the next meeting. This will remind new members in a
 highly personal way that they are welcomed to the meetings and are not just another
 number. Have chapter leadership invite newer members to participate in some specific
 aspect of the next meeting or join a committee based on their unique skills
- Have membership committee volunteers call and check in on unengaged members from time to time. Keeping all members, new and current, engaged will make your membership stronger and chapter activities more rewarding

Canvass current membership regarding what activities they want to participate in.
 Implement those ideas during upcoming meetings and keep track of what works and what doesn't
