Leadership

Finance Committee Recruitment

The California Association for Nurse Practitioners (CANP) is seeking volunteers to fill vacancies on its Finance Committee. The Finance Committee meets quarterly and provides direction to CANP staff regarding the annual budget planning process and make recommendations to the CANP board of directors on the final annual budget and financial policies. The committee also monitors/weighs-in on any non-budgeted-budgeted expenses that occur during the year.

Volunteers will be selected based on chapter location for balanced representation. Previous financial experience is not required but helpful. Committee members must participate in at least 75% of the meetings.

<u>Taxes</u>

It is each chapter's responsibility to apply and maintain federal and state tax-exempt status. As a reminder: if your chapter tax year is calendar year (ending December 31st), please file your federal and California tax returns by March 15th. If you are on fiscal year (ending June 30th), please file your federal and California tax returns by September 15th. Please consult your chapter tax advisor for more detailed information.

Annual Educational Conference

The 40th Annual Educational Conference is being held on March 16-19, 2017 at the Hyatt Regency San Francisco Airport Hotel, located in Burlingame, which is located just 15 miles south of San Francisco. Barbara J. Safriet will be the Opening General Session Keynote speaker, Thursday March 16. Barbara is a Professor of Law at Lewis & Clark Law School, specializing in Health Law & Policy and the Regulation of Health Care Providers. Legislative Advocate Kristy Wiese will present the Legislative Update, Friday, March 17.

The annual awards ceremony will take place on Friday morning and academic organizations/ alumni groups are being asked to participate by hosting their alumni receptions on the evening of Saturday, March 18. In honor of St. Patrick's Day on Friday don't miss the bit of Irish fun incorporated into the day's events.

The Call for Abstracts notice kicked off the initial marketing campaign for the conference. Abstracts submissions are being accepted through August 31.

Chapters will receive the CANP prospectus later this month for distribution to potential new vendors/sponsors.

Advocacy

Legislative Update

After a month-long summer recess, legislators are back in Sacramento for the final weeks of the 2015-16 legislative session, which kicked off on August 1st. With over 1,500 bills remaining for consideration, the pace at the Capitol is hectic as each house rushes to complete its business before the August 31st deadline. Several contentious measures remain for consideration this month, and new bills will undoubtedly pop up over the next few weeks in the form of "gut and amends," a process that allows new language to be inserted into existing bills. August 12th was the fiscal committee deadline, so bills that did not pass out of the Appropriations committees in the opposite house by that date are dead for the year.

Nearly half of the bills initially flagged by CANP for consideration by the Health Policy & Practice Committee (HPPC) are still alive and moving through the legislative process. AB 1795 by former Assembly Speaker Toni Atkins (D-San Diego) passed off of the Senate Appropriations Committee Suspense File, which is where bills that are deemed to pose over a certain cost to the state are placed for further scrutiny. CANP has supported AB 1795 since its introduction because it increases access to breast and cervical cancer screening and treatment for uninsured and underinsured women in California. It will now move to the Senate Floor before heading to the Governor.

In June, the HPPC voted to support SB 123 by Senator Carol Liu (D-La Canada Flintridge), which will improve coordination between state and local health and educational agencies in order to enhance school-based Medi-Cal services, resulting in increased access to healthcare for California's most disadvantaged students. SB 123 passed out of the Assembly Education Committee in June and out of the Assembly Appropriations this month. It will go to the floor for a full Assembly vote.

AB 1306, the bill by Assemblywoman Autumn Burke (D-Inglewood) to expand certified nurse midwives' (CNMs) scope of practice, is also still alive, having recently cleared the Senate Business, Professions & Economic Development Committee. Because of the removal of previous amendments which applied the corporate practice of medicine ban to CNMs, CANP has removed its opposition and is once again supportive of the bill.

SB 323, CANP's sponsored bill that would eliminate physician supervision, failed the policy committee deadline and is dead for the session. After numerous discussions around potential

amendments, consensus regarding the corporate practice of medicine ban could not be reached, so the Assembly Business and Professions Committee hearing for SB 323 was canceled.

The last day of session, which is the last day for all bills to pass in order to advance to the Governor's desk for signature, is August 31st. The Governor has until September 30th to act on all legislation that makes it to his desk during the last two weeks of session.

<u>Grassroots</u>

The legislature has returned for a one-month sprint to the end of session. Legislators will be busy with hearings and floor sessions as the two-year legislative session finishes at the end of the month. After session ends, legislators will be back in their districts and, if they are running for office, their campaign will be in full swing. Now is the time to reach out to campaign offices to volunteer. Chapters can offer to assist with phone banking, canvassing a neighborhood, stuffing envelopes or anything else the campaign needs assistance with. Organizations who volunteer on campaigns make a good impression on candidates.

CANP is asking for chapters to actively engage with legislators at the local level. Some other examples of chapter engagement are:

- Update legislators on the status of SB 323. Either thank them for their support or share wishes for continued conversations
- Invite a legislator to a chapter meeting
- Invite legislators to visit your clinic or practice setting
- Host a fundraiser for your legislator

Additionally, chapters are participating on the monthly Grassroots Advocacy Call the third Monday of each month. During this call, chapters share their grassroots activities and plans for future activities, members' problem-solve concerns or difficulties reaching out to legislators, HPPC updates are shared, members learn of updates and actions needed regarding the BRN as well as information on legislation important to CANP. Each chapter is expected to participate on the call so updates can be provided and information can be taken back and shared with chapters.

CANP continues to urge all chapter leaders to use social media, especially Twitter, as an efficient and effective way of keeping members updated on grassroots opportunities and ultimately engaging legislators. Every morning CANP receives a report of local legislative meetings. When there are such meetings our chapters should attend, we'll post information via Twitter. This presents incredible opportunities to interact with legislators in your area.

CANP's online Action Center helps facilitate social media interaction by providing a quick and easy way to connect with representatives in Sacramento via public posts on Facebook and Twitter or through private connections via email or phone. Members and allies must first visit the new Action Center and sign up to receive Action Alerts that will cue their outreach to state legislators.

Action for Chapters:

- Encourage members to sign up at CANP's online Action Center
- Register for Twitter and follow @CaliforniaNP
- Designate one Legislative Representative per chapter as one key contact for the chapter
- Continue to meet with legislators to educate and develop a relationship with them, with special emphasis on the role that NPs fill in the healthcare delivery system AND how that role is impeded by current requirements for physician supervision


