Advocacy – An Update from CANP's Lobbyist

Legislative Update

The 2018 California Legislative session is now fully underway, and as is typical for this time of year, the focus at the Capitol is on budget negotiations, new legislation, and the policy agendas of new legislators. Over 2,100 new bills surfaced as of the February 16th bill introduction deadline, which is almost 200 more than normal for the second year of a two-year session. Hundreds of those measures were "spot" bills (placeholder measures that only make minor, technical changes to the law), many of which will be substantively amended over the next several weeks. CANP has flagged all of the bills that they believe may be of interest to the Association, and these are populated on the <u>online bill tracker</u>. The California Association for Nurse Practitioners (CANP) Health Policy & Practice Committee (HPPC) will now begin reviewing the bills to identify organizational priorities.

Sexual harassment allegations continue to rock the Capitol, with three Democratic members resigning and one other Democratic member - Assemblywoman Cristina Garcia - on a leave of absence. Garcia, who was the chair of the legislative Women's Caucus and one of the leaders of the #metoo movement, decided to temporarily step away from the Legislature after being accused of sexual harassment and inappropriate behavior toward staff. In the Senate, Tony Mendoza resigned on February 22nd after a leave of absence, following harassment accusations. Mendoza has vehemently defended his actions and plans to run for reelection.

Because of the resignations, Democrats in both houses lost their supermajorities and, consequently, their power to increase taxes without Republican support. Special elections to fill the Senate seats are scheduled concurrently with the June primary election. The Governor has not yet called the special election to fill Mendoza's seat, but one will likely take place in August.

CANP anticipates the 2018 legislative session will include a significant discussion around access to health care and coverage, as well as proposed changes to the health care delivery system. As pressure has increased on Legislators to support single-payer, many Legislators are

looking at alternative proposals to show that California is moving toward universal healthcare. Many of these proposals are not in print yet, but CANP anticipates they will be amended into many of the spot bills that are currently pending.

A major focus this year is a discussion around opioid abuse and what policies California can put in place in an effort to curb opioid abuse and addiction. There are currently 13 bills pending, that focus on the epidemic. CANP may wish to take a closer look at these and identify which may be priorities for nurse practitioners to weigh in on.

2018 Sponsored Legislation

While CANP is not currently sponsoring legislation, we are working on getting a statutory fix change to add nurse practitioners to the list of certified providers in the California Phones Program. The California Phones Program, also known as the California Telephone Access Program (CTAP), is one of the California Public Utilities Commission's (CPUC) Deaf and Disabled Telecommunications Programs. The program serves over 500,000 deaf or disabled Californians in a variety of ways, including amplified phones to make listening to conversations easier, bigger buttons that assist with dialing, and flashing lights that indicate incoming calls.

In order to qualify for the California Phones program, applicants must have a healthcare provider certify their need and sign their applications. Certified providers currently include (among others) physicians, speech-language pathologists, optometrists and physician assistants, but do not include nurse practitioners.

Political Activity

CANP is planning to endorse one of the Democratic gubernatorial candidates before the June primary, a first in the organization's history. A questionnaire has been sent to each of the leading candidates along with an invitation to speak to the CANP Board of Directors.

Grassroots Update

Chapters are focused on engaging membership in meaningful grassroots outreach efforts. On the last Grassroots Advocacy call, Chapters discussed the benefits of "power mapping" their legislators. This is an excellent way learn more about each legislator and to help create on-going relationships with them. Going forward, Chapters should continue to learn more about their legislators, interact with their legislators through meetings, participating in community activities such as town halls, open forums, and legislator sponsored events including but not limited to coffees or walks.

The Grassroots Advocacy Calls take place the third Monday of each month from 7:00pm-8:00pm. The next Grassroots Advocacy Call is scheduled for Monday, March 19.

<u>Taxes</u>

It is each chapter's responsibility to apply and maintain federal and state tax-exempt status. CANP offers the following resources to assist chapters with filing their taxes:

- <u>CANP Chapter Federal & State Filing Exemption Instruction Manual</u> Provides direction in how to verify your chapter's status and other helpful resources
- <u>Ask a Tax Question</u> Allows chapter leaders to ask questions about tax filings and other issues related to financial aspects of running a local chapter

• Twice yearly leadership calls focused on tax filings (January and August).

As a reminder: If your chapter tax year is *calendar year* (ending December 31st), please file your federal and California tax returns by March 15th. If you are on *fiscal year* (ending June 30th), please file your federal and California tax returns by September 15th. Please consult your chapter tax advisor for more detailed information.

Political Action Committee (PAC)

The HPPC will host a PAC raffle booth in the exhibit hall at the Annual Educational Conference, where donations will be accepted. Contributors during the conference will be eligible for a prize drawing to be held during the Saturday evening reception.
