Association Updates

CANP Website Update

The <u>new CANP website</u> went live on Wednesday, September 5. We're receiving many accolades about the new website and we're also very happy with how it turned out.

Please note documents that chapters uploaded to the previous site remain on the new site and can be accessed under the following path: Chapters, Chapter name, Documents. However, the new site does not include functionality for chapters to upload their documents like the previous site did. We are working to provide chapters the best way to upload documents in order to comply with the Alignment Agreement. As you might imagine, there was a great deal of hard work from our team on this effort. From the CANP management team at Shaw / Yoder / Antwih, Executive Director Rob Finley oversaw the effort, Member Services Director Erin Meyer served as the project manager, and Communications Director, Jeff Wagner, Senior Director, Marketing & Business Development, Kim Rothschild, Communications Assistant, Jaye Priest and Events & Education Director, Janneh Johnson, were all integral components of the project. Additionally, we worked with a team of creative and technology partners including our design firm <u>Traina Design</u>, website developer, <u>Blue River Interactive Group</u>, database consultant, Rebecca Evans, and our association management system developer, <u>Euclid Technologies</u>. We would like to thank the CANP Board of Directors and members of the website review committee that was made up of CANP leaders (Theresa Ullrich, Virginia Hass, Sheri Rickman-Patrick, Nancy Trego, Karen Bradley, Carl Wherry, Cynthia Jovanov, Aimee Paulson and Michelle Labbs.)

In conjunction with the launch, in the coming months you'll be seeing new templates for our electronic publications including newsletter *Connections* and all other electronic mailers.

You will notice the Chapter Leadership Toolset was not updated as part of the new website and remains the same as it was on the previous site. The toolset is controlled through the

Association Management System (AMS) and wasn't part of the website upgrade. Several chapters have provided feedback for enhancing the toolset and CANP will be working with a subcommittee of chapter leaders to enhance the toolset beginning later this year.

Membership Campaign

To coincide with the launch of the new website, over 21,600 NPs and our student members will receive a direct mail brochure the last week of September. The goal of the brochure is to generate a sense of pride in CANP for current members and encourage them to visit the new website and for non-members to visit the new website and be compelled to join CANP.

In conjunction with the direct mailer, we are engaged in a three-month social media membership campaign with weekly posts highlighting the new website, benefits, educational offerings, networking, CS II and the Job Center. The membership promotion will culminate with the NP Week membership promotion of two months of free membership for new members and lapse members returning after two years who join in the month of November. Social media will include ads targeted to NP community including NP schools.

Additionally, we are sending targeted emails from President, Karen Bradley asking lapsed members to rejoin CANP. An eblast we sent on September 6 to 1,600 individuals who dropped in the past year with a call to action to visit the new website and rejoin CANP. Another email will be sent in December and June 2019. This effort is part of our outreach to recently dropped members.

Lastly, we are increasing our efforts for membership retention by sending a personalized eblast highlighting member benefits to all new members using our newly designed membership template. This will be done quarterly in an effort to keep new members engaged with CANP within their first few months of joining.

organizations, and liking/retweeting our content as an efficient and effective way of keeping members update on grassroots opportunities and ultimately engaging legislators.

Advocacy – An Update from CANP's Lobbyist

Legislative Update

The California Legislature adjourned on August 31, maintaining tradition by working late into the night to ensure all business in the 2017-18 Legislative Session was completed. Bills that passed in the final weeks before adjournment covered topics ranging from net neutrality, wildfire liability and mitigation, an end to cash bail, renewable energy, and consumer privacy. Other bills stalled, including a voluntary water tax, a bill seeking to regionalize our state's electric grid, and an attempt to change the standard for police use of deadly force. All told, approximately 1,000 bills cleared the Legislature in August and are currently awaiting the Governor's signature.

In what has become customary, the Democrat-controlled Legislature continued to loudly rally against the Trump Administration in 2018, although some nonpartisan issues like the wildfire crisis and the opioid epidemic diverted attention from this objective. The Democrats retained their supermajority in the Assembly despite some vacancies, but lost their Senate supermajority (at least temporarily) due to the recall of Democrat Senator Josh Newman who voted for the gas tax last year. While this likely kept any potential tax increase proposals at bay, some majority-vote progressive proposals did pass.

Healthcare reform was a significant theme this session. SB 562, the bill to enact a singlepayer healthcare system, never made it off the ground. Although that bill died, the Assembly introduced a package of 14 health care reform bills, ranging from Medi-Cal expansion for undocumented immigrants and the establishment of a public option, to cost-sharing limitations, increased access to care and streamlined enrollment. Many of these bills died, including two bills CANP supported that would have expanded Medi-Cal eligibility for undocumented immigrants.

Through the budget process, Assemblymembers also proposed a \$1 billion healthcare package that sought to implement many of the reforms proposed in the aforementioned bill package. Ultimately, the budget proposal was largely scrapped because it lacked the Governor's support. Two components that did pass were funding for an All Payer Claims Database (APCD), as well as funding to establish a task force to study what it would take to accomplish universal coverage.

Opioid Crisis

The opioid crisis was also top-of-mind for many lawmakers in 2018, who introduced over two dozen measures this year to fight opioid addiction. The bills addressed a number of issues, including the CURES database, prescription limits, medication-assisted treatment, prescription labeling and opioid consultation. Over half of these bills cleared the Legislature and await the Governor's signature, but some of the more contentious proposals - including an opioid tax - were unsuccessful.

CANP supported several bills this year that passed out of their respective policy committees but could ultimately not garner enough legislative support to pass to the Governor. Those include AB 2682 (Burke), which would have removed physician supervision of certified nurse midwives while preserving physician collaboration, as well as AB 2965 (Arambula) and SB 974 (Lara) – as mentioned above – which would have made undocumented adults under the age of 26 and over the age of 65, respectively, eligible for full-scope Medi-Cal benefits who would otherwise be eligible for those benefits, notwithstanding their immigration status.

HIPPA

Consumer privacy was also a hot topic this year. On June 28, the California Legislature passed and the Governor signed AB 375, which is sweeping new privacy legislation creating the California Consumer Privacy Act of 2018 (CCPA) that will place numerous additional privacy requirements on businesses and give consumers broad, new rights. This legislation was presented by legislators and stakeholders on June 21 as a "take it or leave it" alternative to the Consumer Privacy Initiative, which would have appeared on the November ballot. June 28 was the last day any initiative could be pulled from the November ballot, so the Governor signed AB 375 just in time for Privacy Initiative sponsor Alastair Mactaggart to withdraw it.

SB 1121 by Senator Bill Dodd is the clean-up bill to AB 375 and is supposed to address the "unintended consequences" of AB 375. Some of those consequences impact the healthcare industry. The business community and some segments of the healthcare and life sciences industries were successful in securing multiple amendments to the bill, including language in AB 375 relating to the HIPAA exemptions, which negatively impacted healthcare providers.

As enacted, AB 375 requires hospitals and healthcare providers to look at each piece of paper or electronic file to determine whether the information it contains constitutes medical information, protected health information, or neither. If neither, it would be subject to the CCPA. This new administrative burden would significantly increase healthcare costs without providing any corresponding benefit to the patient – and HIPAA and CMIA already contain extensive patient rights and privacy protections. For these reasons, Senator Bill Dodd amended his SB 1121 to include all three of these HIPAA fixes. It passed out of the Legislature on the last night of session and is awaiting the Governor's signature.

Now that the Legislature has concluded its business, all eyes are on the Governor as he takes the next month to ponder the nearly 1,000 bills on his desk. Jerry Brown's veto rate over the past several years has hovered around 13%, so most of the proposals awaiting his decision will likely be signed.

<u>Taxes</u>

It is each chapter's responsibility to apply and maintain federal and state tax-exempt status. CANP offers the following resources to assist chapters with filing their taxes:

- <u>CANP Chapter Federal & State Filing Exemption Instruction Manual</u> Provides direction in how to verify your chapter's status and other helpful resources
- <u>Ask a Tax Question</u> Allows chapter leaders to ask questions about tax filings and other issues related to financial aspects of running a local chapter
- Twice yearly leadership calls focused on tax filings (January and August)

As a reminder: If your chapter tax year is *calendar year* (ending December 31), please file your federal and California tax returns by March 15. If you are on a *fiscal year* (ending June 30), please file your federal and California tax returns by September 15th. Please consult your

chapter tax advisor for more detailed information.

Political Action Committee (PAC)

The current balance in the PAC account is \$34,316. CANP encourages chapters to continue to raise funds for the CANP PAC, which is a critical part of the Association's political efforts. PAC funds help show strength in numbers and a commitment to engage in the legislative process.
