AB 890 Implementation

Your continuing participation in CANP helps drive impact, change, and momentum. We are working vigorously – both legislatively and through the regulatory process at the Board of Registered Nursing (BRN) – to ensure AB 890 (Wood) is implemented to the full intent of the bill, allowing nurse practitioners to practice without physician supervision. There are a couple of important updates.

First, AB 852, the follow-up bill to AB 890 also authored by Assemblymember Jim Wood, has become a two-year bill as requested by the bill author. This means it can still move forward in 2022, giving advocates and legislators additional time for key conversations around AB 890 implementation.

Second, CANP is actively engaged in ongoing discussions regarding AB 890 implementation occurring as part of the Joint Legislative Sunset Review of the BRN, as well as at the BRN's Nurse Practitioner Advisory Committee (NPAC), which was established by AB 890. (*Note: NPAC will report to the BRN Practice Committee, which will then report to the full Board.*) The NPAC is charged with drafting recommendations to the BRN with regards to regulations, which will enable the implementation of AB 890.

On July 13, NPAC held a virtual meeting for AB 890 Interested Parties. During public comment, many CANP members participated and voiced their support of AB 890 implementation and NP interests. CANP also submitted a letter for public comment in support of full implementation of the bill. You may view the letter [here](#).

Health Justice Committee

The Health Justice Committee is planning a virtual Town Hall in the late summer and open to both members and non-members to address health justice issues. Additionally, the committee will be adding links on the CANP website that provide resources to address diversity, inclusion, and equity issues. The goal of the committee is to decrease health disparities and to empower NPs in California to be a voice and force for societal and health equity. The group, which currently meets once a month on Zoom, will evolve based on the input, direction and engagement provided by members. This ongoing initiative will be incorporated into future Chapter Leadership meetings.

MEMBERSHIP

Membership Campaign

In the last chapter leadership report, we shared information about a targeted membership campaign we launched through direct mail to all NPs on the BRN list that leverages the impact of AB 890 and the value of membership in CANP. The brochure landed in 22,350 NP households in May.

A subsequent membership outreach effort rolled out in June which targeted new graduates. The second brochure has very specific messaging targeted to NPs just entering the profession and highlights benefits specific to them at the beginning of their career path. The brochure was mailed to over 2,200 individuals.

Another outreach effort is in the works for later this summer which will target the NP schools when classes resume hopefully in person later this year. We are looking to re-engage students and faculty in the fall and possibly offer a membership special to join at a discounted rate as well as resume in-person student membership presentations.

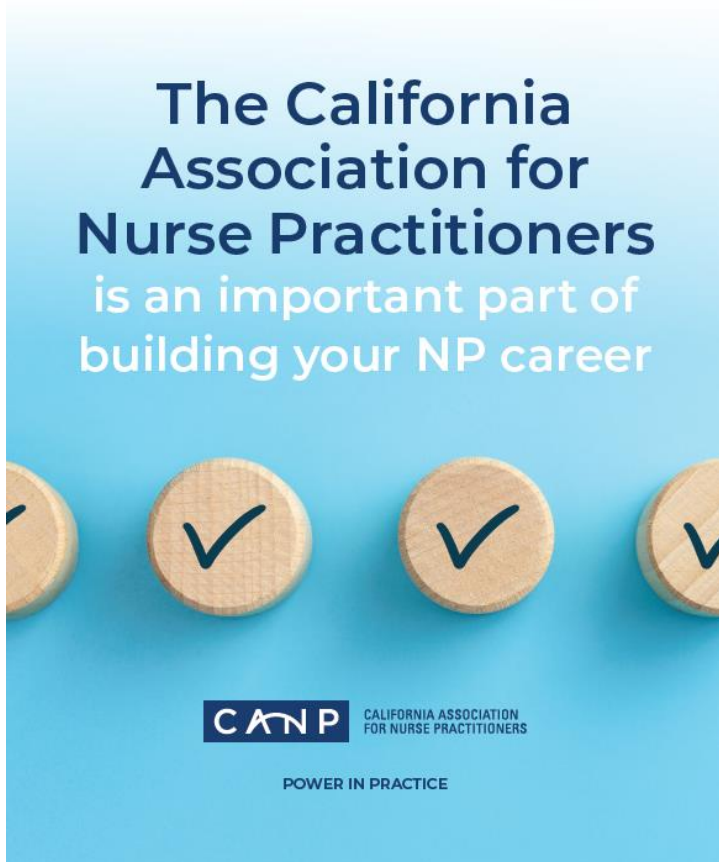


Image 1: Brochure Front

Per Addendum D of the Alignment Agreement, if the compliance measures are not met in any quarter, that quarter’s chapter dues disbursement check will not be issued to the chapter. Also, per terms of the Alignment Agreement, checks will not be distributed retroactively.
