## ASSOCIATION NEWS

### *2022-2024 CANP Board of Directors*

Elected Directors, or ‘officers,’ of the CANP Board of Directors (Board) are selected by the delegates at each House of Delegates (HOD), with the exceptions that the standing President Elect will become President, and the President will become the Immediate Past President. Each of these positions take office automatically.

Appointed Directors are selected by the Board at their first meeting following the HOD. On June 23, 2022, the Board appointed a new Co-Chair, Health Policy & Practice Directors, Co-Chair, Educational Affairs, Membership Chair and Health Justice Chair to office.

## **Advocacy – SB 1375**

CANP-sponsored [SB 1375](#) updates existing law consistent with AB 890 (Wood, 2020) by clarifying that NPs who practice independently can perform first trimester abortions without standardized procedures and clarifies “transition to practice” requirements by specifying that NPs who are licensed after 2023 can begin practicing without supervision, if they meet the criteria specified in existing law.

SB 1375 passed out of the Assembly Appropriations Committee on August 3 and now awaits an Assembly Floor vote, after which it will go back to the Senate for a vote to concur in amendments taken in the Assembly. CANP and our [Close the Provider Gap](#) coalition partners are continuing to advocate diligently to ensure its passage. The bill will be amended to make it clear that nurse practitioners who have more than five years of supervised experience will be authorized to work without supervision, in the settings specified in AB 890.

In preparation for the critical Assembly Floor vote, we encourage you to contact your local Assemblymember and urge support of SB 1375 using [CANP’s Voter Voice](#). We have a template email for you to personalize as well as a phone script if you’d like to call your legislator's in-district office.
