Upcoming BRN Meetings

While CANP achieved a major victory on behalf of California women and families with the signing of SB 1375 into law, there remains much work to be done before trained, qualified NPs can practice without physician supervision in all healthcare settings as established by AB 890 (Wood, 2020).

CANP submitted its comment letter to the Board of Registered Nursing (BRN) on the [proposed regulations](#) pertaining to Categories of Nurse Practitioners and Scope of Practice (AB 890). CANP is supportive of the regulations, recommending only minor technical changes and urging the BRN to swiftly adopt the regulations so that AB 890 can be fully implemented. [Read CANP's comment letter.](#)

We encourage CANP members to participate during the public comment period at the NPAC meeting on **November 1** (where the regulations will be discussed) and the BRN Board meeting on **November 14-15** (where action will be taken), which will both be held virtually. If you can only make one of the meetings, we recommend it be the BRN Board meeting where action on the regulations will be taken.

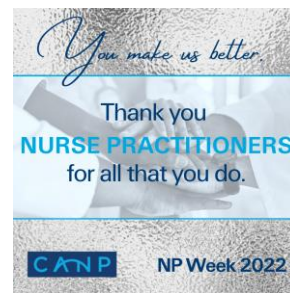
