## BRN's 103 NP Application: Don't Wait, Apply Today!

The California Board of Registered Nursing (BRN) released the new 103 NP application via BreEZe.

As a reminder, AB 890 took effect January 1, 2023, allowing NPs in specified practice settings across California to begin practicing without physician supervision and expand access to much-needed care.
